Recent Projects

Natural Resource Projects:

- The Madison County Health Soil Initiative project continues to assist farmers to improve their soil health through such practices as cover crops, no-tillage/minimum-tillage, variable rate irrigation and variable rate fertilizing.
- High tunnel projects continue to be funded by the NRCS.
- Irrigation pivot systems that provide both water and financial savings to landowners continue to be funded.
- Reduced tillage was applied to 1,846 acres benefiting county landowners.
- Cover crops were used on 2,814 acres assisting landowners to reduce wind erosion and improve soil quality and crop production.
- The Madison SWCD chaired a local working group (LWG) that consisted of four conservation districts and over 30 conservation partners to develop conservation funding priorities.

Educational Programs

- The District hosts an annual conservation tour that highlights conservation efforts in Madison County and eastern Idaho.
- The District sponsored students from Hibbard and Burton elementary schools to attend a "Birth of River" conservation field trip which educated the students on the importance of water as a natural resource.
- The District is working with the NRCS, BLM and the Idaho Department of Transportation to install fuel breaks along highway 33 to reduce the devastating effects of range fires and protect crop land and private homes.
- The District provides administrative assistance to the NRCS that allows the NRCS to provide more assistance and resources to county producers and ranchers.

Future Projects

Madison SWCD continues to focus on the statutory requirement in their annual and 5-Year Plan. Water Quality and Water Resources remains the top resource concern. The Madison SWCD will continue to plan and seek funding for programs such as the Rexburg Bench Energy Savings Program that promote energy and water conservation.

Continued efforts will be made with the assistance of the Natural Resource Conservation Service to address, educate and promote the conservation of our natural resources and to promote such practices as No-Till, Cover Crop, Crop Rotations, Stream Bank Restoration and Wildlife Habitat Improvement.

Our focus will continue to be to conduct educational conservation tours, workshops and local working group planning meetings to gain insight from county leaders and residents to formulate our continuing plan of action concerning natural resource conservation.

Funding from various nontraditional sources is needed to retain the current office level. This includes the Resource Conservation and Development council and administrative fees from potential grants.
