The Clearwater, Idaho and Lewis Soil & Water Conservation Districts would like to request 1,480 hours of Eileen Rowan's Technical Assistance to District's time for FY 2021. We are accustomed to working collaboratively together and feel that a joint application would allow for more collaborative projects and better utilization of Eileen's time.

The activities and associated deliverables that we envision needing at this time are listed below.
Youth & Adult Education: Assistance with youth education events to promote conservation and water quality in our youth. (Earth Day service Clearwater county schools, Kamiah, Clearwater Valley and Julietta schools; Clearwater County 6th Grade Field Trip; Farm & Forest Fair at Greencreek for all area schools; Winchester Field Day services Lewis County schools and Prairie Schools (Cottonwood) – 4 events at a minimum). Assistance with workshops, field trips, tours, information for articles, newsletters and fair booths aimed at adult education. (Minimum of 4 events/articles). (80 hours)

Landowner Technical Assistance: Work with the landowners within our counties to implement all existing and new grants in FY2021 as well as walk-in landowner assistance as needed. Actively seek out grant applications, projects, assist with grant writing and searching for collaborative projects whenever possible. (Minimum of 25 field visits; minimum of 8 new grant application) (1,400 hours).

We would also like to request 600 hours of engineering time from Bill Lillibridge to work on 4 future engineering packages for existing/future projects and field oversight during construction of two culvert projects.


