STAFFING UPDATE

In the last month we have filled two vacancies. June 27th Meghan Brooksher began work as our Emmett-based Natural Resource Conservationist and July was Melonie Ziegler's first day serving as our Financial Specialist, Principal. Staff are excited about everything Meghan and Melonie bring to our team and you will have opportunity to meet them both later during this meeting.

The recent hirings leave us with a three-quarter time Natural Resources Conservationist position vacant. Staff are evaluating where this position can provide the most value to our agency and the Districts we serve and will announce the position when we've determined where to locate it.

WATER QUALITY PROGRAM FOR AGRICULTURE (WQPA) UPDATE

Staff are working with Conservation Districts and landowner participants to complete WQPA grant agreements, which are signed by the sponsoring District and ISWCC, and cost-share contracts, which are signed by the District and the participating landowner. Of the 47 WQPA proposals your board approved for funding, approximately 25% have fully executed grant agreements in place, and approximately 10% have fully executed cost-share contracts. Implementation work has begun on a handful of projects.

Upcoming Commission Meeting Schedule

Below is the tentative Regular Meetings Schedule through November 2022. Meetings are shown in October for scheduling purposes though typically, your Board cancels this meeting to attend Fall Division meetings. The November meeting will be in conjunction with the IASCD Annual Conference in Burley. As has become our tradition, the November Board meeting will be a Listening Session during which Districts are encouraged to bring up and discuss any topic they choose. If additional items come up that need your action, we will add them to the agenda and expand the length of the meeting if necessary.

RE: FY 2023-2026 STRATEGIC PLAN UPDATE

The Commission is required by statute to submit an updated and adopted Strategic Plan annually to serve as a guidance document for the agency over next four years. Last year staff worked with our DFM analyst to complete a thorough revision to the Performance Measure Benchmarks contained in the Strategic Plan and these revisions having been carried forward into the attached draft FY 2023-2026 Strategic Plan.

The Board is required to adopt and submit the Strategic Plan to DFM and LSO each year. In previous years, the deadline for submission was late August (August 27th, last year). However, this year the deadline was moved up to July 1st and your staff failed to catch the change until after your June 21st board meeting. To meet this year's deadline, staff submitted a draft of the updated plan prior to July 1st along with a note informing DFM that if your board directed additional changes be made, we would submit a final version after your July meeting. The only changes staff made to last year's Strategic Plan were changing the dates from FY 2022-2025 to FY 2023-2026. Based on consultation with DFM, staff do not recommend additional changes.

REQUESTED ACTION: Approve the FY 2023-2026 Draft Strategic Plan as presented.
