2024 District Accomplishments

- Annual Soil Health Symposium: Over 120 people attended the 13th Annual Soil Health Symposium organized by Payette SWCD and partners Ada SWCD, Adams SWCD, University of Idaho, and USDA NRCS. Featured speakers presented soil health topics, 2 local producer panels shared their experiences implementing soil health practices, and the opportunities and challenges of the Innovative Agriculture and Marketing Partnership (IAMP) program were presented by the University of Idaho.
- Lower Payette River, and Little Willow Creek TMDLs: A FY2022 Federal 319 grant was completed in the Little Willow Creek watershed in 2024. A combined State Ag BMP and WQPA project was completed converting 35 acres of surface irrigated pasture to a center pivot, increasing irrigation efficiency by 45-55%, and improving water quality in the Lower Payette River which is a tributary of significance to the Snake River. Payette SWCD is working on a phased approach to update an aging drain that serves around 100 users and roughly 2300 acres, allowing drain water to be conveyed to alleviate ponding and sinkholes. The first phase updating a 140' section of failing concrete pipe was completed in 2024.
- **Outreach and Education:** Maintained district website <u>www.payetteswcd.org</u> District supervisors attended and provided input to USDA NRCS in a virtual Local Working Group meeting to identify local natural resource priorities for the federal agency. The district provided an educational display and sponsored a pollinator flower arrangement at the Payette County Fair in August 2024. District supervisors updated their board on Payette County Planning & Zoning issues related to local agriculture and natural resources.
- District Operations: The district maintained an independent, viable district office to provide efficient and effective service to the public. Supervisors attended IASCD Division III meetings, reviewed and approved their 5-Year Plan, and completed required district reports.
