OWL BOXES TAKE OFF!

A recent student alumnus of Gooding High School and advocate for the Gooding Soil Conservation District, Madison Crawford Vargovich, wrote an article on owl boxes and the pros and cons. Madison contacted the Gooding SCD about the success of producers in our area who have begun utilizing owl boxes on their agricultural properties to see if providing owls with nests will help with the overabundance of voles.

Supervisor, Joe Pavkov purchased five owl boxes about three years ago and installed them in the desert surrounding his property, in more secluded areas, hoping less traffic would entice the owls. He explains that voles are abundant near each of the owl boxes, so he is unsure why the owls haven't nested in them yet.

Pavkov also mentions that a producer in the neighboring county has some success with their owl box, with one nesting earlier this year, which gives him hope that it will work. Bill Bitzenburg, a grower in the Filer area, purchased an owl box from the GSCD and has been impressed by the number of rodents the owls have hunted. Bitzenburg shares that the owl box has been occupied for the past two summers, not only by barn owls but by great horned owls as well. He shared pictures of the annual cleaning of the owl box this fall, which showed a pile of owl pellets - the undigestible parts of the rodents the owl's hunt. The presence of owl pellets in the owl boxes proves the owls are doing their job in working to control the rodent population.

When properly maintained annually, owl boxes do have the ability to aid in rodent control in agricultural areas, resulting in fewer damaged crops, pastures and lawns.

NRCS Resource Conservationist, Dinah Reaney Helped explain the EQIP process and what was approved last year.



The Gooding and Wood River Soil Conservation District continue to follow up on the 14 landowners who utilized the Soil Moisture probe program in 2023.

We combined efforts to help inform landowners of new technology available to them. The project would help landowners manage their water & give them tools that can inform them when to irrigate, how to apply, as well as when to plant or harvest. The district held a workshop after the first season, even though we didn't install the probes until July, so we didn't receive much data. However, the landowners in the project continued to use them and gave great feedback.

The workshop was intended for every landowner to ask questions and learn how to read and retrieve the data applied on their phones & computers. Jarum Eghan and Misty Tucker from Soiltech were there to listen to problems and concerns of each landowner. They even brought new antennas, batteries etc. to get things working if they had issues.



NEW SHED GOING UP FOR THE GOODING GARDEN



The Gooding Soil Conservation District applied for and received funding from St. Lukes CHIF program to continue adding new elements to the garden. We will utilize the shed for storing much of our equipment but also will apply this for outdoor events as we plan to add a canopy / patio.
