No-Till Drill Rental

With the purchase of a no-till drill funded through a DEQ grant, the NBSCD successfully launched a rental program to make the equipment available to local producers. In FY 2025, the no-till drill was used on over 1,000 acres, promoting low-impact planting practices that improved soil health and supported sustainable land management across the district.

Completion of the Blackfoot Nitrate Project which consisted of a field tour, work shop, and booth at Shelley's Annual Spud Day. This project provided outreach and education to residents and land managers within the Blackfoot Source Water Protection Area.


