
Education Efforts



The Snake River SWCD co-sponsored a cover crop project, with the Twin Falls SWCD, to plant a cover crop trial at the University of Idaho Kimberly Research and Extension Center. The trial is looking at different planting dates and species to see how growth and survivability is impacted by planting date. A tour was held at the site in early October.

Educational Efforts

- Held the poster contest for 4th, 5th and 6th grade students in which over 150 students from four schools participated
- Sponsored an environmental education day for the Murtaugh and Hansen 3rd classes at the historic Stricker Ranch/Rock Creek store.
- Held a speech contest for high school students in the fall of 2025.
- Participated in the 2025 Twin Falls County Fair.
- Sponsored a WQPA to help convert gravity irrigated fields to sprinkler to reduce irrigation-induced erosion.



The Snake River SWCD is offering a cover crop cost-share program to growers to help encourage greater adoption of cover crops.

One of the key principles of soil health is to include livestock when possible. This field is located along a busy stretch of Highway 30 where people have watched the cover crop grow and then see how sheep were utilized to graze it in the late fall/early winter.


