Teton SCD is committed to supporting local organizations. The Teton High School FFA is one that we continue to support offering a match grant for a greenhouse built on the school property. We also have asked the FFA to partner with our 2026 Farm Tour as well as working to put together an Envirothon team for 2026.

The Teton Basin Water Users Association is also supported by TSCD by participation and ongoing outreach to farmers in Teton Valley. The association is a unique group of farmers, conservationists and local government, working to address dwindling aquifer levels due to growth. Using programs like incidental recharge early season to boost summer supply.
