District Outreach and Grant Activity

North Fork Payette River Watershed Coalition A USBR WaterSMART Cooperative Watershed Management Program (CWMP) Phase I wrapped up in 2025 with the NFPR Watershed Assessment and Action Plan, available on VSWCD website Valleyswcd.org. Public input of watershed concerns into an interactive map on our website valleyswcd.org is still appreciated. Workgroups organized around the public's top five concerns: Stream Conditions, Land Use and Development, Stormwater Management, Wastewater Management and Climate Resiliency. Results of Coalition efforts and final Assessment and Action Plan is also incorporated into the 2025BSU/Valley County Resilience Strategy Plan.



Normal Reservoir operations, filling and lowering water levels create steady bank erosion and annual inputs of phosphorus, sediment and nutrients into the reservoir, contributing to Harmful Algal Blooms.

EPA Closing America's Wastewater Access Gap (CAWAG) with South Lake Recreational Water & Sewer District mapping and process of locating test wells.

IDEQ 319 Water Quality Grant Projects -NFPR Bank Improvements at Heinrich Lane, Alzar, Depot and Cascade Strand

Planting days with new student groups, IDFG, Trout Unlimited and VSWCD. **NFPR Alzar new student groups** IDFG and VSWCD cut willow stakes for Alzar riverbanks then contributed 2025 community service hours along the Cascade Strand completing fence work and dryland plantings to decrease access ramp erosion.

IDEQ 319 Water Quality Grant Project - Brush Creek

Progress Site Visit indicates near 100% plant survival rate. One final planting Fall 2025 with 200 potted Alder and Dogwoods completes the bank restoration portion of the project. Final grant reporting due

NRCS 2025 EQIP contracts totaling \$44,000- 2 new high tunnels were installed within the District and one forest health/wildfire risk reduction project. Additionally, one livestock virtual fence project was approved in VSWCD NRCS Annual Local Workgroup meeting includes VSWCD Supervisor John Lillehaug to determine EQIP funding allocations.



Lake Irrigation District receives Aging Infrastructure grant and NRCS EQIP to replace open ditch with covered pipeline. VSWCD is administering this important project.
