## **RECENT PROJECTS**

### **Natural Resource Projects:**

- Water Quality Program for Agriculture (WQPA) with Fremont/ Madison Irrigation district. This helped fund the automation and data acquisition equipment for the Twin Groves canal headgate and the Enterprise Canal headgate, as well as flow measurement station at the end of the Enterprise Canal where it returns flow to Moody Creek. This has enabled them to manage water supplies more effectively and has reduced water diversion from the river and provided a more consistent flow.



## **EDUCATIONAL PROGRAMS**

- The Yellowstone SCD continues to work with its conservation partners contributing, educating and participating in schools with Envirothon
- The Yellowstone SCD supports learning about conservation in all county school including Earth Day.

## EDUCATIONAL PROGRAMS

- The Yellowstone SCD sponsored a field trip for two classes at Parker/Egin Elementary where they saw the birthplace of the Henry's Fork River, learned about natural springs. They got to see Johnny Sacks cabin and learn his use of the land. They went to Island Park dam and had speakers from Fremont Madison Irrigation District teach them about water conservation. They then went to Harriman State Park and learned about ecosystems, wildlife and the type of soils that are found in the Island Park Caldera.

- Henry's Fork Foundation WQPA Conant Creek Canal water quality and quantity project.
- Fremont Madison Irrigation District WQPA Teton River automated diversion dam to improve irrigation efficiency.
